As provided in this Court's Order entered on May 27, 2026, this constitutes the jury trial calendar for the trial week of July 13, 2026 through July 17, 2026.

The cases listed on Exhibit "A" shall constitute the trial calendar for the trial week listed above in the order listed. All cases shall appear on Monday, July 13, 2026 at 9:30 o'clock A.M. ready for trial. Jurors will be reporting on Monday, July 13, 2026 at 1:00 o'clock P.M. Counsel should expressly note that the Court has scheduled two (2) days prior to the trial week for pleas to be taken, June 18, 2026 and July 10, 2026. Any Motions that require a hearing shall be scheduled for July 10, 2026. The party filing the Motion shall be responsible for causing a Rule Nisi to issue for that date.

The Court will likewise accept pleas from any Defendant whose case was listed on the Calendar Call for June 10, 2026 but which is not listed on this Trial Calendar, on June 18, 2026 and July 10, 2026.


In all cases listed both the State and Defense have announced "ready for trial." This announcement represents that all discovery has been produced and exchanged or will be produced and exchanged prior to trial, and that all witnesses are available. Should there be an issue with discovery by defense counsel the Court shall be notified in writing (e-mail acceptable) on or before July 6, 2026 with a copy to the State. No continuance or removal from the Trial Calendar shall be granted except for good cause, and any such request shall be submitted to the Court in writing, with

the reasons for such request being specifically set forth therein. A copy of any such request shall be served upon opposing counsel, and opposing counsel shall have twenty-four (24) hours to submit a response. Thereafter, the Court shall either grant or deny the request.

Should the Court receive conflict notices from counsel, the Court will consult with the Courts in conflict and counsel will be notified in such event if the Court(s) in conflict agree for counsel to appear in Madison Superior Court on the date and at the time designated. In this regard, counsel **shall strictly comply** with Rule 17.1(B) of the Uniform Rules for Superior Courts.

Copies of this Order are being sent to counsel, to the State and to Defense Counsel by regular mail and by electronic delivery; to the Defendant by regular mail at the address provided in the Clerk's file; and to the bondsman by regular mail at the address provided on the bond.
