ORDER FOR CRIMINAL CALENDAR CALL, MOTION DAY AND TRIAL WEEK

IT IS HEREBY ORDERED: A calendar call will be conducted by the Court on August 8, 2022, to be conducted in the Courtroom of the Madison County, Georgia Justice Center, Danielsville, Georgia, commencing at 9:30 A.M. **Those Defendants, and Counsel, set forth on Exhibit "A" attached hereto shall appear before the Court at the time designated on Exhibit "A".** Should there be a need to participate remotely, defense counsel shall contact the District Attorney's Office for the purpose of making the necessary arrangements.

The Court shall receive the announcements from counsel as to the status of the case, and the announcements shall include the Court being advised of any Motions which are pending and which require hearing. The Court expects any issues/matters which require a hearing to be heard prior to the commencement of the trial week. The Court will also be available at the calendar call to accept pleas throughout the day at a time permitted by the schedule.

As further clarification, at the Calendar Call the Court desires four (4) questions to be answered by Counsel for the State and Defense:

1. Are you ready for trial? Counsel should expressly note that an announcement that counsel is "standing on a not guilty plea" is not the same as announcing ready. Further, an announcement of "Ready for Trial" represents that all discovery has been received, collected, produced and exchanged by both the State and the Defense. The Court expects to know that counsel is, in fact, ready for trial.

2. If counsel is not ready, Why? For example, is there a witness availability problem, is there a discovery issue, or is there some other reason that counsel is not ready?

3. What Motions/ Matters are presently pending that need to be heard prior to trial?

4. Is counsel aware of any conflict under the Uniform Rules of Superior Court that need to be considered in setting the calendar for Order of Trials?

The Court will conduct hearings on any pending Motions on October 4, 2022, commencing at **9:30 o'clock A.M.**, in the Courtroom of the Madison County, Georgia Justice Center. It shall be the responsibility of the moving party to cause a Rule Nisi to issue, and the Clerk of Superior Court and/or her designee shall be authorized to sign the Rule Nisi on behalf of the Court. Motions which are pending but which are not scheduled by rule nisi for hearing on October 4, 2022 are subject to being dismissed. The Court will also be available to accept pleas, negotiated and otherwise, on October 4, 2022.

The Court presently has three (3) jury trial weeks scheduled for the balance of the calendar year 2022: September 6-9; October 31-November 4; and November 28-December 2. The week of November 28-December 2 will be for civil cases; **provided however**, if there should be no civil cases for trial, the Court will schedule criminal cases for trial that week. The other two (2) weeks for which jury trials are scheduled shall be criminal trials exclusively.

Following the calendar call on August 8, 2022, a Trial Calendar setting forth the order of cases for trial will be published and disseminated. The Trial Calendar may or may not include all cases listed on the Calendar Call, depending upon the announcements made. Further, the position

of the case on the Calendar Call is not necessarily the position that the case will have on the Trial Calendar.

Jurors will begin reporting on the first day of each trial week at 1:30 o'clock P.M., with the Court being available to take any pleas, negotiated or otherwise, beginning at 9:30 o'clock A.M.

Due to the events of COVID 19 and the consequent backlog of criminal cases, no Leave of Absence filed after August 10, 2022 shall be approved except for medical or family emergencies.

No continuance will be granted except upon good cause shown, and any such request shall be presented at the calendar call on August 8, 2022.

Conflicts with other Courts shall be immediately provided to this Court in order that the conflict may be resolved between the Judges. Conflict notices shall strictly comply with Rule 17.1 of the Uniform Rules for the Superior Courts.

Copies of this Order are being sent to the District Attorney's Office, the Public Defender's Office, Conflict Counsel, Private Counsel of Record, the Defendant and the Bondperson as their addresses appear in the Clerk's file.
