ORDER FOR CRIMINAL CALENDAR CALL, MOTION DAY AND TRIAL WEEK

IT IS HEREBY ORDERED: A calendar call will be conducted by the Court on August 9, 2021, to be conducted in the Courtroom of the Madison County, Georgia Justice Center, Danielsville, Georgia. Those Defendants, and Counsel, set forth on Exhibit "A" attached hereto shall appear before the Court **at the time designated** on Exhibit "A". Should there be a need to participate remotely, counsel shall contact the District Attorney's Office for the purpose of making the necessary arrangements.

The Court shall receive the announcements from counsel as to the status of the case, and the announcements shall include the Court being advised of any Motions which are pending and which require hearing. The Court expects any issues/matters which require a hearing to be had prior to the commencement of the trial week. The Court will also be available to accept pleas.

As further clarification, at the Calendar Call the Court desires four (4) questions to be answered by Counsel:

1. Are you ready for trial? Counsel should expressly note that an announcement that counsel is "standing on a not guilty plea" is not the same as announcing ready. The Court expects to know that counsel is ready for trial.

2. If counsel is not ready, Why? For example, is there a witness problem, is there a discovery issue, or is there some other reason that counsel is not ready?

3. What Motions/ Matters are presently pending that need to be heard prior to trial?

4. Is counsel aware of any conflict under the Uniform Rules of Superior Court that need to be considered in setting the calendar for Order of Trial?

The Court will conduct hearings on any pending Motions on September 21, 2021 in the Courtroom of the Madison County, Georgia Justice Center, commencing at 9:30 A.M. It shall be the responsibility of the moving party to cause a Rule Nisi to issue, and the Clerk of Superior Court and/or her designee shall be authorized to sign the Rule Nisi on behalf of the Court. The Court will also be available on that date to accept pleas.

The Court will also be available to accept pleas on September 7, 2021, and on November 3, 2021 subsequent to the Court's completing its civil motion calendar.

Any plea desired to be entered after 5:00 o'clock P.M. on November 3, 2021 shall be a blind plea.


The Court will conduct criminal jury trials the weeks of November 8 - 12, 2021 and November 15 - 19, 2021. Following the calendar call on August 9, 2021 a Trial Calendar setting forth the Order of cases for trial will be published and disseminated. In setting that calendar priority will be given to 1) cases in which speedy trial demands have been filed; 2) cases in which an accused is being held without bond; 3) the seriousness of the crime(s) charged; and 4) the age of the case; not necessarily in that order. The Trial Calendar will not include all cases listed on the Calendar Call. The Trial Calendar will list no less than three, nor more than five, cases that are to appear ready for trial on Monday, November 8, 2021. All other cases set forth on the Trial Calendar will be on twenty-four (24) hour call for trial for the two week trial term, except for cases which may be specially set for trial on a date and at a time certain.

Jurors will begin reporting on Monday, November 8, 2021 at 9:30 o'clock A.M., and on Monday, November 15, 2021 at 9:30 o'clock A.M.

Due to the events of COVID 19 and the consequent inability to conduct jury trials for more than one year, no Leave of Absence of which the Court does not, on this date, have notice of shall be approved except for medical or family emergencies. No continuance will be granted except upon good cause shown, and any such request shall be presented at the calendar call on August 9, 2021. Conflicts with other Courts shall be immediately provided to this Court in order that the conflict may be resolved between the Judges.

Copies of this Order are being sent to the District Attorney's Office, the Public Defender's Office, Conflict Counsel, Private Counsel of Record, the Defendant and the Bondperson as their addresses appear in the Clerk's file.
