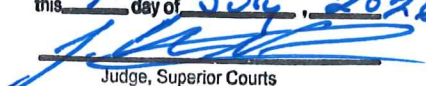

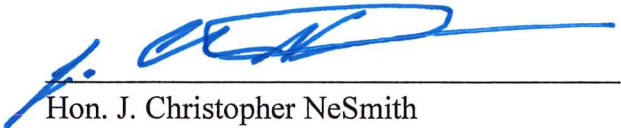
The Misdemeanor Status Calendar shall be comprised of all open misdemeanor cases on Judge J. Christopher NeSmith's docket.
