ORDER SPECIALLY SETTING CASES FOR TRIAL

IT IS HEREBY ORDERED THAT the series of cases set forth on the attachment hereto and labeled as “Exhibit A,” shall constitute the two-week Jury Trial Calendar. The first week shall begin on August 8, 2022 at 9:00 a.m. The second week shall begin on August 22, 2022 at 9:00 a.m. All cases listed on Exhibit “A” shall appear on August 8, 2022 at 9:00 a.m., ready for trial. All cases listed on Exhibit “B”, as well as any cases listed on Exhibit “A” but not reached during the week of August 8, 2022, shall appear on August 22, 2022 at 9:00 a.m., ready for trial;

CALENDAR CALL

IT IS FURTHER ORDERED THAT the Court shall have a Calendar Call for any case listed on the Jury Trial Calendar on **July 25, 2022 beginning at 9:30 A.M.** in the Courtroom of the Madison County Courthouse. All cases listed on Exhibit “A” shall appear at 9:30 a.m. for the Calendar Call. All cases listed on Exhibit “B” shall appear at 1:30 p.m. for the Calendar Call. All Attorneys and Defendants SHALL APPEAR for this Calendar Call. If Defense Counsel and/or Defendants wish to appear via Webex, Defense Counsel shall contact the District Attorney’s office to arrange for an online invitation. The State shall coordinate with personnel of the Georgia Department of Corrections and/or personnel of the Madison County Jail to facilitate the participation of any incarcerated defendants.

The Court shall reserve the right to change or otherwise modify the Jury Trial Calendar thereby affecting the priority in which cases are to be tried, and all attorneys of record and defendants shall remain subject to one day’s notice of recall by the Court throughout the duration of the Jury Trial Calendar.

Any agreed upon resolution of a case on the Jury Trial Calendar subsequent to the date of this Order shall be immediately reported by the District Attorney’s Office to the Court by telephone at (706) 376-7151 or by email to the Judicial Administrative Assistant at tfleming@franklincountyga.gov. The Court will, upon receiving such notice, communicate to Counsel on the case(s) next in priority on the Jury Trial Calendar, and inform said Counsel that its



position has advanced and, that Counsel and Defendant shall appear on the date and at the time designated by the Court, ready for trial.

No leave of absence shall be approved throughout the duration of the Jury Trial Calendar, except for emergency circumstances. No continuance or removal from the Jury Trial Calendar shall be granted except for good cause, and any such request shall be submitted to the Court in writing, with the reasons for such requests being specifically set forth therein. Should the Court receive conflict notices from Counsel, the Court will consult with the court(s) in conflict and Counsel will be notified in such event if the court(s) in conflict agree for Counsel to appear before the Madison County Superior Court on the date and time designated.

The Clerk of Superior Court shall send copies of this Order and Exhibit to the State, the Public Defender's Office, and all private defense attorneys and commercial Bonding Companies via email, and to Defendants and Private Bondsmen by U.S. Mail.
