**SECOND AMENDED SCHEDULING ORDER FOR CRIMINAL TRIAL WEEKS
BEGINNING MARCH 10, 2025 AND SEPTEMBER 29, 2025**

A Scheduling Order was issued on March 26, 2024 scheduling Judge Malcom's July 8, 2024 and March 10, 2025 trial weeks and pretrial dates. That Order is hereby **AMENDED** to modify the pretrial dates previously scheduled for the March 10, 2025 trial week; to add a trial week for the week of September 29, 2025, as well as pretrial dates; and to add additional defendants as follows:

IT IS HEREBY ORDERED THAT:

The cases set forth on Exhibit "A" attached hereto shall constitute the Trial Calendar for the week of March 10, 2025, subject only to any jail cases and cases in which statutory speedy trial demands have been filed. A Calendar Call will be held on January 14, 2025. The Court will hear any pending Motions on February 19, 2025. The Court will accept any negotiated pleas on March 5, 2025. All three (3) of these dates shall commence at 9:30 A.M. in the Courtroom of the Madison County Government Complex. Counsel and the parties are thus *not* required to be present on February 19, 2025 or March 5, 2025 absent the intent to enter a plea or the hearing of a Motion(s). Absent notice provided to the Court on January 14, 2025, the Court will presume that defense counsel is in touch with and has accurate contact with Defendants/clients.

The cases set forth shall be called for trial in the Order listed, again subject to any jail cases and cases in which statutory speedy trial demands have been filed. Counsel and the parties shall be ready for trial, including having witnesses subpoenaed and available.

It shall be the responsibility and obligation of the moving party to cause a Rule Nisi to issue for the hearing of any pending Motion(s) for February 19, 2025 or Plea(s) for March 5, 2025. Any pending Motion(s) or Plea(s) not scheduled and brought for hearing on said dates, absent good cause shown, shall be considered abandoned.

On or before March 6, 2025, the Court will email attorneys and pro se defendants to notify which cases are to report. All cases not directed to report the Monday of the trial week will be subject to a one-day call, meaning parties will be told to report the day before they are to appear in court for trial. This will not necessarily be 24-hour notice.

The Court will *not* accept negotiated pleas of which the Court has not been previously advised after March 5, 2025, at 5:00 P.M.

ANY CASE NOT REACHED DURING THE MARCH 10, 2025 TRIAL WEEK IS HEREBY ORDERED TO REPORT READY FOR TRIAL ON THE SEPTEMBER 29, 2025 CRIMINAL TRIAL WEEK. A CALENDAR CALL WILL BE HELD ON JUNE 20, 2025. THE COURT WILL HEAR ANY PENDING MOTIONS FOR SAID TRIAL WEEK ON AUGUST 27, 2025 AND WILL ACCEPT ANY NEGOTIATED PLEAS ON SEPTEMBER 23, 2025. ALL OF THESE DATES SHALL COMMENCE AT 9:30 A.M., IN THE COURTROOM OF THE MADISON COUNTY GOVERNMENT COMPLEX, DANIELSVILLE, GEORGIA. IT SHALL BE THE RESPONSIBILITY AND OBLIGATION OF THE MOVING PARTY TO CAUSE A RULE NISI TO ISSUE FOR THE HEARING OF ANY PENDING MOTION(S) ON AUGUST 27, 2025 OR PLEA(S) ON SEPTEMBER 23, 2025. ANY PENDING MOTION(S) OR PLEA(S)

NOT SCHEDULED AND BROUGHT FOR HEARING ON SAID DATES, ABSENT GOOD CAUSE SHOWN, SHALL BE CONSIDERED ABANDONED. THIS IS THE ONLY NOTICE YOU WILL GET.

On or before September 24, 2025, the Court will email attorneys and pro se defendants to notify which cases are to report. All cases not directed to report the Monday of the trial week will be subject to a one-day call, meaning parties will be told to report the day before they are to appear in court for trial.

This Order sets forth eight (8) dates:

For the March 10, 2025 Trial Week

Calendar Call on January 14, 2025

Motion Day on February 19, 2025

Plea Day on March 5, 2025

For the September 29, 2025 Trial Week

Calendar Call on June 20, 2025

Motion Day on August 27, 2025

Plea Day on September 23, 2025

No continuance or removal from the Trial Calendar shall be granted except for good cause, and any such request shall be brought to the Court's attention on June 20, 2025. Counsel shall **strictly and timely** comply with Rule 17.1(B) of the Uniform Rules for Superior Courts in regard to any conflicts for all eight (8) dates set forth.

Jurors will report on Monday, March 10, 2025 at 9:00 A.M., in the Courtroom of the **Madison County Government Complex**, Danielsville, Georgia, for jury selection and the trial of cases. For the September 29, 2025 Criminal Trial Week, jurors will report on Monday, September 29, 2025 at 9:00 A.M., for jury selection and the trial of cases.

The Clerk of Superior Court shall send a copy of this Order to all Defendants, bondsmen, and attorneys.
